 - a. Gave overview of pool repairs / improvement progress

 - d. Strip of grass on Janet Horton’s property, needs more care from Yard-Nique, also more care for grass clippings and leaves in fall so they don’t beat up their yard.
 - i. Janet – Suggests taking over ownership of little strip of grass
 - ii. Tony – Probably can’t have own ownership of these due to liabilities, but need to speak with Yard-Nique to improve services. Board to address.
 - e. Playground – setup a finance plan for families to flex out budget for playground redo going forward. Is this possible?
 - i. Suggested from community to query the boy scouts / local high schools for service projects for outside help.
 - ii. Tony – Still open to helping supervise a project.

iii. Dave Bohm – To head up subcommittee for playground process going forward. Get sub-committee info from D. Bohm.

- b. Car break-in (unlocked cars) – board suggested community to lock cars.
